TERMS AND CONDITIONS SAMSUNG GALAXY Z FOLD8 ULTRA / Z FOLD8 / Z FLIP8 /WATCH ULTRA2 / WATCH9 “BUY AND TRY” PROMOTION SAMSUNG ELECTRONICS

Participants agree to be bound by these terms and conditions (the “**Terms and Conditions**”). Any information or instructions published by the Promoter about the Promotion at <https://samsungoffers.claims/buyandtry2026> form part of the Terms and Conditions.

The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 2000 Hillswood Drive, Chertsey, Surrey, KT16 0RS (the “**Promoter**”).

Purchase Period

2. The Promotion will run between 14:00 (BST) on 22nd July 2026 and 23:59 (BST) on 8th September 2026 (“**Purchase Period**”).

Eligibility

3. To be eligible to participate in the Promotion you must be an individual and lawful resident (aged 18+) (“**Individual Participant**”) of the United Kingdom (including Isle of Man and Channel Islands) or Republic of Ireland (“**Territories**”) or a business with an address in the Territories (“**Company Participant**”). For the avoidance of doubt, within these Terms and Conditions the term ‘Participant’ shall be taken to refer to both Individual Participants and Company Participants (and the applicable plural) unless stated otherwise.
4. Employees or agents of the Promoter that are involved in the operation of this Promotion or anyone professionally connected to this Promotion are not eligible to enter.
5. Network providers, retailers, distributors, resellers and any person who purchases a Promotion Product (defined below) for resale or otherwise not as the end user of the Promotion Product, may not participate in this Promotion.
6. Claims may only be submitted directly by the end user Participant (or in the case of a Company Participant its authorised representative). Claims made on behalf of an Individual Participant by any third party are specifically excluded.

Offer

7. A Participant who purchases a selected new (i.e. not refurbished, ex-display or second hand) SIM free Samsung Galaxy Z Fold8 Ultra, Z Fold8, Z Flip8, or Watch Ultra2, Watch9 40mm or 44mm including bespoke models, listed in Table 1 below (“**Promotion Product**”) from any of the retailers listed <https://samsungoffers.claims/buyandtry2026> (“**Participating Retailers**”) during the Purchase Period may, provided they have completed a valid registration within 30 days of purchase or (in the case of pre-orders) delivery, submit a Claim (as defined below) between 45 and 100 days after purchase (or delivery for pre-orders) (“**Return Period**”) to send in their Promotion Product in exchange for a cashback payment (“**Cashback**”) equal to the lesser of the price paid for the Promotion Product (less any discounts, published enhanced trade in values, or the value of any free gifts) or the maximum value (RRP) shown in next to the corresponding Promotion Product in Table 1, provided the returned

Promotion Product meets the Acceptance Criteria (see condition 11 below) and subject to full compliance with these Promotion Terms and Conditions. The Cashback will be paid in GBP or EUR (depending in Territory) to the bank account nominated on the Participant's Claim form which must match the details in the Claim exactly. The Return Period begins on Day 45 after purchase or delivery (as applicable) and Promotion Products may not be returned through this Promotion offer before this period commences. For multi-product or bundled purchases, the Cashback will only cover the purchase price of the Promotion Product.

8. Each Individual Participant may claim a maximum of one (1) Cashback payment per eligible Promotion Product returned in accordance with these Promotion Terms, and for each household up to four (4)

Claims may be submitted. Company Participants may claim up to ten (10) Cashback payments for the corresponding number of Promotion Products purchased and returned in accordance with these Promotion Terms.

9. This Promotion does not replace or affect any statutory or other warranties or return rights that Participants may have. Participants should contact the Participating Retailer from whom it purchased the Promotion Product if it is defective, or if they wish to return the Promotion Product within the returns period offered by the retailer.
10. The Participant's receipt or proof of purchase must clearly show the Participating Retailer's name, the name of Promotion Product purchased, the price paid and the date of purchase. By making a Claim for Cashback, the Participant provides authorisation for the Promoter or its service providers to contact the relevant Participating Retailer to check details shown on a receipt or proof of purchase.
11. In order for the Participant to receive a Cashback payment the Promotional Product must be sent in meeting the following minimum criteria ("**Acceptance Criteria**"):
 - i. Complete with its original box, accessories and paperwork, including the charging cable;
 - ii. Undamaged (with the exception of fair wear and tear, such as minor scratches or other signs of light use);
 - iii. Unlocked, with any passwords removed and biometric or personal data erased;
 - iv. Not permanently marked or dented;
 - v. Not recorded as stolen or the subject of any insurance claim.
12. By participating in this Promotion, the Participant agrees to transfer ownership in the Promotion Product to the Promoter. Ownership shall transfer when the Promoter receives the Promotion Product.

Claims

13. To take part in the Promotion and make a claim for Cashback in respect of the purchased Promotion Product ("**Claim**"), Participants must first register ("**Registration**") on the website <https://samsungoffers.claims/buyandtry2026> within thirty (30) days of the purchase date (or delivery date in the case of pre-orders) and follow the onscreen instructions providing the required information including proof of purchase receipt showing the price paid, and photographic evidence of the Promotion Product IMEI number.
14. Participants who wish to trade in their purchased Promotion Product for a Cashback payment must have completed a valid Registration and then must revisit the Website and click on the "Return" button to complete the request process during the Return Period (including by inputting their GBP/EUR bank account details matching the name on the Registration and Claim form).
15. Claims must be submitted within the Return Period.
16. Participants who submit a valid Registration will be sent an email and SMS to confirm receipt by the Promoter and after completing a valid Claim will be notified of provisional validation pending receipt of the Promotion Product meeting the Acceptance Criteria. Participants whose Claims have been provisionally approved shall also receive instructions for packing and shipping the Promotion Product. UK Participants who are returning a Smartphone will receive a returns bag and prepaid shipping label, with a QR code to arrange collection through DHL, and UK participants who are returning a Watch will receive a QR code and instructions to return their product through Royal Mail. ROI Participants will be contacted with instructions on arranging DHL collection with a provided returns label. For the avoidance of doubt, the Promotion Product must be securely packaged in the original box, including all foam inserts or protective materials, and properly sealed prior to shipping or collection by the

courier. Shipment and receipt of the device must be made within thirty (30) days of the provisional approval and said instructions.

17. If the email or SMS acknowledgement referred to in Condition 16 above has not been received, it is the Participant's responsibility to contact the Promoter's customer service team on +44 0333 070 7761 (UK) or +353 1800 903 337 (ROI) or buyandtry2026@samsungoffers.claims.
18. If any of the information submitted is deemed to have not been submitted correctly or details such as the relevant IMEI number cannot be verified, the Participant will be notified via email and SMS and offered the opportunity to provide the required information for validation (which may include a photograph of the Promotion Product IMEI number) within seven (7) days of such notification. If no response is received within that time frame, the Claim shall be marked as invalid and the Participant will no longer be eligible to receive the Cashback.
19. Participants must dispatch their Promotion Product and it must be received within thirty (30) days of the Claim being provisionally approved. Promotion Products shipped and received outside of this date shall be deemed ineligible for a Cashback payment.
20. Registration or Claims that are incomplete or damaged will be deemed invalid. No responsibility is accepted by the Promoter for lost, delayed or damaged data which occurs during any communication or transmission of Claims.
21. Please note returned Promotion Products sent via means other than as instructed or delivered by hand will not be accepted.
22. If the Promotion Product is received in a condition that meets the above Acceptance Criteria in full, the Participant's Claim will be validated and the Cashback amount paid equal to *the lower of* the price paid for the Promotion Product (less any discounts, published enhanced trade in values, or the value of any free gifts) or the cap as in Table 1 above. If the Promotion Product is not received within the required time frame (provided in Condition 19, as thirty (30) days from the date of provisional approval and shipping instructions), the Claim will be rejected and no Cashback paid. The Cashback amount is also subject to revaluation as determined by the condition of the Promotion Product received and where it does not meet the Acceptance Criteria, the Promoter may offer a lower amount or refuse the Claim and return the Promotion Product at no cost to the Participant. Where the Participant rejects a reduced Cashback offer, the Promotion Product will be returned to them free of charge and no Cashback paid. The Promoter shall notify the Participant of any rejection or reduced Cashback offer within ten (10) days of receipt of the Promotion Product.
23. Providing that the Participant has complied fully with the Promotion Terms and the returned Product meets the Acceptance Criteria, the Promoter shall pay the Participant the Cashback amount via bank transfer to their bank account as nominated during the Claim process within forty-five (45) days of receipt of the Promotion Product.
24. Cashback payments are non-modifiable and cannot be exchanged or substituted for alternatives, nor can the payment be assigned to another person. Only the purchaser and legal owner of a Promotion Product is eligible to take part in the Promotion.
25. This Promotion cannot be used in conjunction with any other Samsung promotion offering cashback or any other reward based on the purchase of the same Promotion Product.
26. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid Claims including, without limitation, to generate or require further verification as to proof of purchase, as well as the identity, age, and other relevant details of a Participant. This process may involve the Promoter sharing information with third parties. Any claims that are illegible, fraudulent or are not in accordance with these Terms and Conditions will be considered invalid and will be definitely rejected. In the event of a fraud or confirmed fraud, the

Participant will not be able to benefit from further Samsung promotional offers for a minimum period of three (3) years.

Privacy and Data Protection

27. Other than as set out in these Terms and Conditions or for the purposes of operating the Promotion, the details and information provided by the Participant when entering the Promotion or claiming the Cashback will not be used for any promotional purpose, nor shall they be passed to any third party.
28. The Participant may withdraw consent to such use of personal information by writing to the Promoter or by using the opt-out process outlined in the Promoter's privacy policy, available at www.samsung.com/uk/info/privacy.html.

General

29. The Promoter shall not be liable for any interruption to the Promotion whether due to *force majeure* or other factors beyond the Promoter's control.
30. The Promoter reserves the right, acting reasonably and in accordance with all relevant legislation and codes of practice, to vary the Terms and Conditions of the Promotion.
31. The Promoter will not be responsible or liable for: (a) any failure to receive submissions due to transmission failures and other conditions beyond its reasonable control; (b) any late, lost, misrouted, or damaged transmissions or claims; (c) any computer or communications related malfunctions or failures; (d) any disruptions, losses or damages caused by events beyond the control of the Promoter; or (e) any printing or typographical errors in any materials associated with the Promotion.
32. The Promoter's maximum liability to any Participant in connection with this Promotion is limited to the value of the Cashback that would be due to the Participant if these terms were complied with.
33. Participants will be solely responsible for any and all applicable taxes and any other relevant costs or expenses which are not stated in these Promotion Terms and Conditions as included in the Cashback payment.
34. This Promotion is governed by the laws of England and Wales.
